Parent Payment Arrangements 2022 – Year 7

Hawkesdale P12 College is looking forward to another great year of teaching and learning and would like to advise you of our voluntary financial contributions for 2022.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that's through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Within our school this support has allowed us to organise and coordinate the best possible programs outside of the traditional teaching and learning classroom structure. These financial contributions assist us with the purchasing of art, physical education equipment and resources, upgrading our digital device program, which in turn supports them to be exemplary programs coinciding with our elite classroom teaching of the established subjects such as Reading, Writing and Maths.

Other programs which we are able to offer because of your contributions include the drama program/school production, robotics, and the variety of welfare programs and events such as the Colour Run and Hands on Learning. We have also been able to provide air conditioning in all classrooms for additional comfort for our students, and to subsidise our swimming program. All of these programs running alongside the traditional classroom teaching and learning programs are imperative so as to provide an effectively balanced and rigorous overall education for your children.

Educational items for students to own - Booklists

The school recommends that you purchase book listed items from Campion Education for your child to individually own and use. Many of you will know that a new system and ordering process was introduced in late 2020. There is no longer a paper version of the booklists.

In order to meet current COVID regulations Campion has outlined the preferred process for ordering booklists for 2022:

These options apply to orders placed by the due date. You will be advised at the time of submission which options are still available.

Option 1. Parents/guardians of students attending Hawkesdale P12 College in 2022 are to access the booklist (for the relevant year level) via a link on the Compass Parent Portal.

Parents to submit the order online, with payment made at the time of submission.

This option includes free postage for all orders placed by Sunday 12th December, after that date a \$15.95 postage and processing fee applies. This allows for efficiency of delivery and COVID safe processing.

Option 2. Parents/guardians of students attending Hawkesdale P12 College in 2022 are to access the booklist (for the relevant year level) via a link on the Compass Parent Portal or school website. Parents will need to pay for the booklist online and then collect at 169 Fairy Street Warrnambool from Monday 18th January 2022. This option includes a \$5.95 processing fee.

Option 3. Parents/guardians of students attending Hawkesdale P12 College in 2022 to contact Campion staff at the Warrnambool store directly on 03 5562 9400 or inquire onsite at 169 Fairy Street Warrnambool to arrange collection of booklist items with payment made on the day. Campion Education Retail Service Centres may have restrictions on the number of people allowed in its stores; unfortunately this may result in delays.

Orders need to be placed **online by Sunday 12th December 2021.** After this date, parents will need to use 'click and collect' and collect from the Warrnambool store. There will not be a book 'distribution' day. Payment is made directly to Campion Education.

ONE PAGE OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
